Dear Brethren:

With the passing of Passover and the Feast of Unleavened Bread, those who have fulfilled their obligations before God in good faith have peace of mind and confidence going forward into this new year. For all of the pressure that we may feel in preparing for the spring Holy Day season, what a joy to have obeyed and to have received the promised blessings for faithful compliance. Above all, a thankfulness for the meaning of these symbols in God's plan helps to keep us focused on the ultimate purpose for all that exists around us, and the hope we have for the coming Kingdom of God under the rule of Jesus Christ. Repeating that salvation plan again by the observance of these annual Holy Days is a perpetual duty of the people of God, and truly, it is a respect for God's Sabbaths which sets apart the faithful from all others. Not one of us is without sin or fault, and we each need the mercy of Jesus Christ's shed blood daily.
